## **SNAPCHAT FUGITIVE ARRESTED AT KENNYWOOD**

PITTSBURGH, PA – Sheriff William P. Mullen announces the apprehension of Kimberly Dolan, 19, of Munhall, PA. Dolan was wanted on an Allegheny County criminal bench warrant, issued May 25, 2017, for criminal attempt homicide for violation of bond conditions.

On January 14, 2016, Dolan was arrested for striking one victim and running over a second victim with her car at a Munhall gas station. Following the incident, one of the victims told authorities they were involved in a verbal argument with Dolan, when the actor got into her car, circled the area and drove back to attack the victims. Both victims were wounded in the altercation. The victim who was run over by Dolan sustained serious bodily injuries. Following the incident, Dolan confessed to police, saying she could hear the victim stuck under her vehicle.

On May 7, 2017, Munhall police officers were dispatched to the 100 block of 9th Avenue for a reported vehicle accident with no injuries. At the scene, they encountered a female victim whose face and forehead were badly bruised and bleeding. The victim said she called 911 after a van ran a stop sign and hit her vehicle. The driver of the van subsequently exchanged insurance information with the victim and drove away from the scene. As the victim was waiting for authorities to arrive, Dolan pulled up to the victim and accused her of hitting her grandfather's van. As the woman attempted to explain the incident, Dolan struck the victim in her right eye, nose and several other places on her face, leaving the scene before authorities arrived. The victim was subsequently taken to the hospital and diagnosed with multiple facial fractures, a broken nose and contusions to the forehead. Dolan was subsequently charged with aggravated assault, harassment and disorderly conduct.

Sheriff's deputies and several other police agencies have been searching for Dolan since a warrant was issued for her arrest on May 25, 2017. At approximately 4:20 p.m. yesterday, Dolan began posting photos to Snapchat, which showed her and her child at the Kennywood amusement park in West Mifflin, PA. Deputies observed the pictures and while en route to the park, they contacted West Mifflin police, who were at the location working a detail. Dolan was found inside the park and arrested without incident.
