FUGITIVE COUPLE NABBED IN EAST HILLS

PITTSBURGH, PA – The Allegheny County Sheriff's Office announces the apprehension of Imonte Kendrick, 20 years of age from Braddock. Kendrick was wanted on three warrants; two bench warrants due to a parole/probation violation and an arrest warrant for a Forgery charge in Kennedy Township.

In 2015, Kendrick pled guilty to Unauthorized Use Motor/Other Vehicles and Possession of a Controlled Substance. The following year, he pled guilty again, this time to Possession of Firearm Prohibited and Firearms Not to be Carried without a License. Due to part of the negotiations regarding the guilty pleas, Kendrick was placed on probation.

However this past September Kendrick allegedly attempted to use counterfeit funds to make a purchase at a state store in Kennedy Township, which in turn violated the terms of his probation/parole.

Over the course of the last few days, sheriff's deputies began to investigate the whereabouts of Kendrick, which began in the Verona area of town, as he has family in the area. Upon further investigation, deputies realized he had since left the area and believed he was now residing in the Wilkesburg/East Hills


region.

This morning deputies were able to track Kendrick to an address in the 2200 block of East Hills Drive. Deputies announced themselves at the address and were met by the leaseholder of the residence. Upon a brief search of the home, Kendrick was found in a third floor bedroom with his girlfriend, Ania Posey, 23 years of age. Both Kendrick and Posey were taken into custody, without incident, as Posey was wanted on an arrest warrant out of the City of Pittsburgh for an alleged Burglary earlier this year.

The fugitive couple was transported to the Allegheny County Jail where Kendrick will be arraigned on new charges and lodged on his bench warrants. Posey will await arraignment on her charges, as well.
